Workshop participants will engage in an interactive case that will develop throughout the workshop and have different objectives (e.g., assessing a proper level of care, and then incorporating a harm reduction treatment orientation with the client in regards to their MAT decision process).

2018 Rule Adoption for NJ LPCs, LACs, LCSWs, LSWs, LMFTs & LAMFTs (1 Hour Opioid Education)

New Jersey recently passed a Rule Adoption that requires all LPCs, LACs, LCSWs, LSWs, LMFTs and LAMFTs to receive 1 hour of continuing education on opioid use disorders (treatment, assessment and diagnosing, the societal problem impact). This course meets that continuing education requirement! This course covers the history of prohibition, differentiation of opiates and opioids, medication assisted treatments for opioid use disorders, and the dangers associated with use.

He is a Licensed Professional Counselor, a Licensed Clinical Alcohol/Drug Counselor, a Certified Clinical Supervisor, and an Approved Clinical Supervisor. For 15 years, Glenn served as the Executive Director of Hunterdon Drug Awareness Program, Inc. As Executive Director, Glenn continued to hold a clinical caseload and perform clinical services in addition to his other administrative duties. Glenn specializes in working with clients who have co-occurring substance use disorders, depressive disorders, and anxiety disorders. Glenn served as an expert panel member for a SAMHSA TIPS book on treating sub-acute anxiety in the substance using population.

Since 1999, Glenn has been teaching on many courses including a 45 hour clinical supervision workshop series, Emerging Drugs of Abuse, and The ASAM 3 Criteria. Glenn teaches nationally and is currently a trainer for the Change Companies (the folks who publish the ASAM 3 Criteria Book). Glenn authored a chapter on the use of live supervision in a community treatment organization for the book entitled "The Use of Technology in Clinical Supervision and Training: Mental Health Applications," (2016).
