### LGCAGA Requirements for the CPCS

1. Licensure as an LPC in Georgia
2. The certification requires that the LPC has been held in GA for a certain period of time. The period of time determined by the graduate degree that was used to obtain the LPC (**NOTE: this is a requirement from the GA Composite Board of Professional Counselors, Social Workers, Marriage and Family Therapists**).
  - 3 years with a Master's degree
  - 2 years with a Specialist degree
  - 1 year with a Doctoral degree
3. Application fee of \$150.00. This fee is waived if you are a current Clinical member of LPCAGA.
4. Training Requirements - (3 training options).
5. Two Professional References from Licensed Georgia Clinicians.

### Certified Professional Counselor Supervisor (CPCS)

*This workshop series will be a live, interactive webinar based event using the Zoom platform. This format has been approved the LPCAGA and the GA composite board. The workshop series will occur on the same date and time as the live in-person workshops.*

### Who needs it and why get the Certified Professional Clinical Supervisor Credential?

According to the GA Composite Board Rules an LPC who can be considered a qualified supervisor for Licensed Associate Professional Counselor (LAPC) will change starting **October 1, 2018**. According to GA board rules 135-5-.01 and 135-5-5-.02 **"as of October 1, 2018 a supervisor who is a Professional Counselor must hold either a National Board of Certified Counselors (NBCC) Approved Clinical Supervisor credential or a Licensed Professional Counselors Association of Georgia (LPCAGA) Certified Professional Counselor Supervisor credential (CPCS)."**

In April, 2023 the LPCA increased the number of required contact hours for the CPCS from 24 to 30 contact hours. This workshop series has been approved by the LPCA to meet those 30 contact hours of required clinical supervision. This workshop series also meets 30 of the 45 required hours for the national ACS (Approved Clinical Supervisor) certification.

Glenn has been providing clinical supervision for 28 years and most recently served as the Executive Director for an outpatient co-occurring capable program from 2003 - 2018. Glenn continues to provide clinical supervision as part of his private practice. Glenn specializes in working with clients who have co-occurring substance use disorders, depressive disorders, and anxiety disorders. Glenn served as an expert panel member for a SAMHSA TIPS book on treating sub-acute anxiety in the substance using population.

Since 1999, Glenn has also specialized in, and has developed a 24 to 45 hour workshop series clinical supervision. He is a leading behavioral healthcare lecturer on clinical supervision. Since 1999, he has continuously developed and taught this clinical supervision curriculum for Rutgers University among other organizations. He has consulted with organizations on how to enhance and implement best practice clinical supervision strategies. Glenn authored a chapter on the use of live supervision in a community treatment organization for the book entitled "The Use of Technology in Clinical Supervision and Training: Mental Health Applications," published in 2016. **New CPCS Training Requirements**

**In April 2023, the LPCAGA Board approved changes to the CPCS training, which now includes 30 hours of training. This 30 hour workshop series has been approved by the LPCAGA and in compliance with the new CPCS educational standards recently approved.**

The LIVE workshops will run from 9 a.m.– 4:30 p.m. (1 hour for lunch (lunch is not provided).

**Each day's brief objectives:**

1. **Foundations of Clinical Supervision** (the roles & functions of supervision, best practice approaches, effective use of feedback & the supervision process).
2. **Core Issues in Effective Supervision**- Virtual Supervision home and other technology issues are discussed as well as other issues in effective clinical supervision.
3. **Models and Methods of Clinical Supervision** (five different supervisory models, group vs. individual supervision issues, methods of supervisee oversight).
4. **Managing Differences and Difficult Populations** (influence of individual, cultural and developmental differences between supervisors and supervisees, areas where difficulties with supervisees arise, progressive discipline policies /due process).
5. **Legal and Ethical Issues in Clinical Supervision** (legal & ethical issues in GA LPC regulations as well as LPCAGA supervision regulations).
