This course has been approval for the 3 hour Legal Standards requirement for LCADCs/CADCs by the NJ Alcohol and Drug Committee on 12/17/21!

New Jersey requires that all LCADCs/CADCs complete 3 hours of legal standard training every 2 year renewal period. N.J.A.C. 13:34C-5.2(d) states that all LCADCs and CADCs complete the 3 hours in legal standards course. Licensees and certificate holders will be required to demonstrate completion of the 3 credit course to renew for the 2022-2024 biennial period.

Now we have to have this course completed every 2-year renewal cycle. You have until July 31, 2026 to complete this mandatory requirement. It will have to be completed every 2-year renewal cycle.

For 15 years, Glenn served as the Executive Director of Hunterdon Drug Awareness Program, Inc. As Executive Director, Glenn continued to hold a clinical caseload and perform clinical services in addition to his other administrative duties. Glenn specializes in working with clients who have co-occurring substance use disorders, depressive disorders, and anxiety disorders. Glenn served as an expert panel member for a SAMHSA TIPS book on treating sub-acute anxiety in the substance using population. In December of 2021 Glenn was approved by the NJ-ADC committee to provide both the 3-hour and 6-hour legal standards training, and he is currently certified by the NJ Certification Board as an approved mandatory legal class trainer; certification #: 003.
